ZEYTİNBURNU SAMİHA AYVERDİ ANATOLIAN HIGH SCHOOL PANDEMIC (COVID-19) RISK LIST

- 1. Exposure to illness due to inadequate or incorrect information leading to erroneous behavior resulting in illness and increased spread of the epidemic.*
- 2. Delayed notifications resulting in transmission before a diagnosis is confirmed, leading to illness and increased spread of the epidemic.*
- 3. Insufficient precautions resulting in the entry of the epidemic into the workplace and its national-scale expansion.*
- 4. Transmission due to inadequate general hygiene leading to illness and rapid spread of the epidemic.*
- 5. Failure to take necessary precautions during visitor reception resulting in virus transmission to employees, illness, and increased spread of the epidemic.*
- 6. Employees continuing to work while infectious and transmitting illness to healthy workers, resulting in illness and increased spread of the epidemic.*
- 7. Transmission and illness due to lack of adherence to social distancing in work areas, resulting in increased spread of the epidemic.*
- 8. Exposure to the virus, illness, and spread of the epidemic due to crowded and unprotected attendance at meetings.*
- 9. Failure to ensure isolation and delayed first aid intervention for individuals showing signs of illness during work, resulting in increased cases.*
- 10. Transmission to high-risk employees resulting in illness and increased spread of the epidemic.*
- 11. Increase in the number of cases due to carrier employees who do not show symptoms but transmit the disease to others during the infectious period by not adhering sufficiently to personal hygiene rules.*
- 12. Employees' failure to adhere to personal hygiene practices leading to transmission.*
- 13. Failure to disinfect work areas, equipment, and social areas used by employees who leave work due to suspected illness, resulting in transmission to other employees.*
- 14. Inability to maintain accurate records of individuals who contract the disease during the pandemic, failure to identify possible contacts, and spread of the epidemic.*
- 15. Failure to keep appropriate records resulting in missed actions, repetition of activities, and wastage of resources, and failure to conduct activities dynamically.*
- 16. Lack of an emergency action plan or ineffective measures resulting in the entry of the epidemic into the workplace and the national escalation of the epidemic, increasing losses.*
- 17. Increased susceptibility to illness due to psychological problems arising from the pandemic, leading to incorrect behaviors in health and social life and the emergence of psychosocial hazards.*
- 18. Increased losses and expansion of the epidemic due to the illness of groups at risk during the COVID-19 pandemic.*
- 19. Risk of transmission of infectious/epidemic diseases due to lack of COVID-19 related training for students and employees.*
- 20. Risk of transmission of infectious/epidemic diseases due to lack of disinfection of service vehicles during the COVID-19 pandemic.*
- 21. Risk of transmission of infectious/epidemic diseases due to operation of air conditioners in service vehicles in recirculating mode during the COVID-19 pandemic.*
- 22. Risk of transmission of infectious/epidemic diseases due to lack of hand antiseptics in service vehicles during the COVID-19 pandemic.*

23. *Risk of transmission of infectious/epidemic diseases due to failure to regularly disinfect work environments.*
24. *Risk of transmission of infectious/epidemic diseases due to insufficient disinfection of common areas (toilets, stair handrails, faucet handles).*
25. *Risk of transmission of infectious/epidemic diseases due to failure of students and employees to wash their hands frequently or using incorrect methods.*
26. *Risk of transmission of infectious/epidemic diseases due to lack of natural ventilation in work environments.*
27. *Risk of transmission of infectious/epidemic diseases due to failure to conduct periodic health screenings for support services and supplier personnel.*
28. *Risk of transmission of infectious/epidemic diseases due to employees disregarding general hygiene rules and working collectively.*
29. *Risk of transmission of infectious/epidemic diseases due to sharing of personal belongings by students and employees without adhering to general hygiene rules.*
30. *Risk of transmission of infectious/epidemic diseases due to lack of disinfectants in common areas to ensure hand hygiene against COVID-19 transmission.*
31. *Unsuccess to contact the responsible person when an employee is exposed to COVID-19 risk.*
